About the Family Law Fair

The Alberta Family Lawyers Association and the University of Calgary Faculty of Law Career and Professional Development Office hosts an annual Family Law Fair to introduce students to the benefits of working in the field of family law. Historically, and venue-dependent, the event is open to 30 students and 30 representatives of family law firms and organization representatives.

Event Goals

The University of Calgary Faculty of Law student body is made up of our diverse student body of over 430 students. The goals of this event include:

- Promote family law firms in Alberta to University of Calgary Faculty of Law students
- Provide an opportunity for Family Law firms in Alberta and law students to network and expand their professional connections
- Create an avenue for law students interested in careers practicing Family Law firm to connect with potential employers

Event Overview

The Family Law Fair invites representatives from small, mid-sized, and regional family law firms from in and around Calgary Alberta to join students from the University of Calgary's Faculty of Law for an afternoon of networking and discussion on the benefits of a career in family law.

Past events have included a brief invitation-based panel discussion, followed by attendee networking and socializing. The event agenda typically follows this format:

Opening Remarks and Sponsor Highlights: 10 minutes

Panel Presentation and Discussion with Q&A at the end: 50 minutes

Networking Reception: 1 hour

Q: Does my firm need to be actively hiring to attend the Family Law Fair?

No! We welcome attendance from small, mid-sized, and regional firms regardless of their hiring goals. The purpose of this event is for students to learn more about the experiences of lawyers who practice in the field of family law. Of course, we always hope that your interactions with our students spark your interest in employing a summer student or articling student in the future, but you do not need to be actively hiring to attend this event.

Q: How is the Family Law Fair Day different than a Career Fair?

Unlike a Career Fair, employer attendees do not bring promotional materials or set up booths at this event – but this is offered to sponsors should they want an opportunity to market. The format of the event includes a panel discussion and non-alcoholic cocktail-style networking. This event encourages students and employers to move throughout the room, instead of congregating around employer-specific booths.
